Dear Everett City Council,

If you live in the State of Washington your tax dollars are being used to build a new baseball stadium in downtown Everett, Washington.

In fact, the City of Everett is taking money from the State of Washington Department of Commerce Youth Athletic Facility Account and using it to subsidize billionaire Major/Minor League Baseball owners.

This means parks and playfields that might have been funded by the Youth Athletic Facility Account cannot be funded. The account funded parks and k-12 fields not only in Everett, but in Lynnwood, Mountlake Terrace, and many more communities across the State.

Youth Athletic Facilities funded 24 projects with the same amount of funds now being used for the "New Stadium" in Downtown Everett (see email below). The Everett Parks & Facilities Department funded 6 projects through the Youth Athletic Facilities Program.*

Everett City Council, please terminate the Youth Athletic Facility Account grant (Contract Number: 24-96531-002), especially since contract documents indicate the City of Everett plans to apply for additional grant program funds anyway.

Everett City Council, propose and help pass the following statement:

"We, the Everett City Council and governing body for the City of Everett, terminate the Everett New Stadium Project, Contract Number: 24-96531-002."

Send the statement to the Washington State Department of Commerce.

Simply explain that it is completely inappropriate to use Youth Athletic Facility Account funds to build a new baseball stadium in downtown Everett that subsidizes billionaire Major/Minor League Baseball owners.

Submit final performance and financial reports to the Department of Commerce and return unspent money.

It's not complex. It's really pretty simple.
