John,

Thank you for copying me on all the information in the past 24 hours. I appreciate your efforts to raise the awareness level of various aspects of this project.

To my knowledge, there has been no pro forma financial projection provided to the public that shows whether or not the downtown baseball stadium will pencil out and be able to support the anticipated debt service that mayor Franklin has talked about publicly. She has mentioned issuing bonds for \$50 million. I know from experience at Angel of the winds Arena what the debt service requirements are on an annual basis and that is based on interest rates that we locked in several years ago that were quite favorable. Those sorts of rates are no longer available so the debt service on the baseball stadium downtown would be substantially higher.

I do not understand how the city can continue to spend what is I believe so far is at least \$7 million without a financial projection, at least at a high-level with certain assumptions plugged in.

Until we see such a document, city resources have been put in jeopardy.

Dear Scott Pattison,

Did cost estimates for the Everett Outdoor Multipurpose Facility Downtown Project exist during the DEIS period?

Were cost estimates for the Everett Outdoor Multipurpose Facility Downtown Project withheld from the DEIS?

Why were there NO cost estimates in the DEIS or Final Environmental Impact Statement for the Alternative 2: Downtown Site Action Alternative Everett Outdoor Multipurpose Facility Downtown Project?

Why did you (Scott Pattison) not inform the council on June 11, 2025, that an AECOM Hunt detailed DEIS cost estimate (\$29,431,281 and \$39,341,332) was listed in the DEIS -- EVERETT AQUASOX FUNKO FIELD RENOVATION SCENARIO #1?

Why did you tell the council on June 11, 2025, "Nobody has come to us with any viable options on how we could make the school district site work."

Why did you (Scott Pattison) tell the council on June 11, 2025, that you were under a SEPA EIS study, "strict Code of Silence."

At the Everett City Council Meeting on June 11, 2025, you (Scott Pattison), the Mayor's Office Special Projects Manager, indicated:

".... but if you recall for about 12 months we were doing a SEPA EIS study, where we were under a strict Code of Silence so we couldn't have communications with anybody, uh, with regards to the project."\*\*\*

There is NO SEPA "strict Code of Silence" included in the Everett Municipal Codes:

EMC 15.02.130 Notice of SEPA determinations  
EMC 15.02.200 Hearing examiner procedures  
EMC 19.41.040 Compliance with SEPA and other laws

According to the Washington State Department of Ecology, there is nothing in the WAC that specifically restricts communications about an EIS in progress.

By including only the lower cost "Funko Field Action Alternative" and excluding the higher cost "Downtown Site Action Alternative," it appears the impartial nature of the SEPA process has been undermined.

It appears the Everett City Council has inappropriately been made prejudiced in favor of the "Downtown Site--New Construction."

In an extended conversation with Everett City Council President Donald Schwab, I pointed out that Refurbishing Funko Field involves a potential savings of over \$100 million dollars for the taxpayer -- a substantial taxpayer savings.

At the same Everett City Council Meeting on June 11, 2025, Everett City Council Councilmember Scott Bader asked;

".... since the financial feasibility committee ...work was completed (December 5, 2024), has anyone come to the city with a viable thought about how we could close that funding gap if we were to choose Funko?"

You (Scott Pattison), special projects manager with the City of Everett, answered:

"No. Nobody has come to us with any viable options on how we could make the school district site work. Nobody's come to us with not, not even viable, with any options."\*\*\*\*\*

Support for Refurbishing Everett Memorial Stadium - Funko Field - in Everett, Washington as a viable option was submitted to all members of the Everett City Council and made part of the public record on May 27, 2025, months after "... the financial feasibility committee ...work was completed" (December 5, 2024). The email and pdf file\* specifically indicated:

"Refurbish the current stadium — Funko Field — on Everett School District property, have the AquaSox and Major League Baseball continue paying more than \$100,000 per year in rent to the Everett Public School District, and after Funko Field is refurbished, establish an increased rental rate to be paid to the Everett Public School District based on the new fair market rental value of Funko Field."

Why did you (Scott Pattison) not inform the council on June 11, 2025, that an AECOM Hunt detailed DEIS cost estimate (\$29,431,281 and \$39,341,332) was listed in the DEIS -- EVERETT AQUASOX FUNKO FIELD RENOVATION SCENARIO #1?

Why did you tell the council on June 11, 2025, "No. Nobody has come to us with any viable options on how we could make the school district site work."

Why did you (Scott Pattison) tell the council on June 11, 2025, that you were under a SEPA EIS study, "strict Code of Silence."

Will the City of Everett obnoxiously use the Department of Commerce "Youth Athletic Facility Account" to subsidize Major League Baseball owners by funding "design build" for the City of Everett Outdoor Multipurpose Facility Downtown Project?

Dear Mayor and Mayoral Candidate Cassie Franklin,

Thank you for providing me with the links and additional information.

Still, your cover letter to the Final EIS that I sent to you previously, remains with a broken website link.

As I indicated previously, this is not conducive to transparency, public participation, or even the legal framework under which we operate.

I was hoping your email was in answer to my earlier questions:

1). Does the City of Everett have anything in writing from the AquaSox that says the AquaSox will leave town without a new or renovated stadium?

Your answer remains No. The City of Everett does not have a written statement or from the AquaSox that states the AquaSox will leave Everett if Major League Baseball requirements noted in the "design build" application are not met.

2). How much is the fine?

Major League Baseball (MLB) has a policy that Minor League (MiLB) teams - the Aquasox - have to pay a fine if their stadium isn't up to snuff. Much to do was made of this in the press.

How much is the fine? Was the Major League Baseball fine just levied and then suspended? Or was the fine actually paid? Did you see the cancelled check or receipt for the fine?

Your answer remains No. The City of Everett does not have a cancelled check or receipt for the fine paid by the AquaSox to Major league Baseball.

In the meantime, please ask Scott Pattison to:

1. Promote renovation of Funko Field, a solution that meets Player Development League (PDL) Facility Standards and also provides amenity and fan experience enhancements instead of promoting Major League Baseball stadium requirements and marketing objectives.
2. Give full attention to "viable thoughts" submitted by citizens and others that enhance the renovation of Funko Field and explain that there is no "funding gap" when Funko Field is renovated.

- 4 publish a complete and accurate revenue model.
- 5 publish a complete and accurate economic model.

I request that you reset the clock on the public comment.

At the June 11, 2025, Everett City Council meeting your "team" member, Scott Pattison, indicated:

"All the information that I even inherited when I started in August of 2023 has been put on the web page. So yeah, all the work that FAC ( financial advisory committee ) completed is on the web page. All of our community attributes which was the economic impact statement that was put together is on the website. Yeah all at work that we've done today is on this website."

The City of Everett website link to this critical and comprehensive information was, and still is, broken in the Final EIS dated November 6, 2024. The link says:

"We're sorry, but there is not a web page matching your entry.

This is not conducive to transparency, public participation, or even the legal framework under which we operate.

Moreover, the "economic impact statement" Scott Pattison referred to - Appendix F -- does not appear in the Final EIS.

I've attached the final EIS with the Everett City introduction letter for your review.

At the same June 11, 2025, Everett City Council meeting, Councilmember Judy Tuohy indicated:

"And I assume from what you spoke of earlier that you've done some Revenue forecasting also.

And is that something that we'll share with the council? ...Because we haven't yet. So..."

Scott Pattison, replied "Absolutely," and then went on to explain that to him, "absolutely" actually meant "summaries of those Revenue projections."

Councilmember Judy Tuohy continued, "...have you guys started on a Performa for the operations of the facility once it's completed?... (and)... will you share that with the council?"

"Yes" said Scott Pattison to which Councilmember Judy Tuohy replied,

"Okay. When?"

I've been waiting for that for a long time.
