Dear Allie Lindert,

Thank you for your gracious hospitality and for taking time to speak with me at the Everett Public Facilities District meeting on October 22, 2025, at 9 AM in the Edward D. Hansen Conference Center.

As I pointed out, you are in an awkward position since you do not work for the Everett Public Facilities District. You work for a private sector company, Oak View Group.

It wasn't perfectly clear that you understood that I wanted the written comments I gave to you, submitted to the Everett Public Facilities District as part of the public record for the Everett Public Facilities District meeting on October 22, 2025, at 9 AM in the Edward D. Hansen Conference Center. You indicated that you would give them to your boss, who I assume is Corey Margolis of the Oak View Group.

I asked that you give the written comments directly to an Everett Public Facilities District Board member or a member of the Everett Public Facilities District staff that is employed directly by the Public Facilities District. The first page of those written comments is attached as a pdf file.

In your emails to me you indicated:

"With the request of whom the Public Records Officer is, I Allie Lindert would be the contact for that."

and

" Per my message sent at 10:56 AM this morning, I confirmed that I am the Public Records Officer for the Everett Public Facilities District."

I asked you, "When were appointed Public Records Officer for the Everett Public Facilities District?"

I would appreciate it if you could forward me a dated letter from a member of the Everett Public Facilities District staff that is employed directly by the Public Facilities District or Public Facilities District Board member(s) that appointed you as the Public Facilities District Public Records Officer.

As I pointed out, the Washington State Records Act requires that public records officers complete training within 90 days of assuming their role. In my view, the training should be paid for by the employer.

Washington State has a specific certification for public records officers called the Certified Public Records Officer (CPRO) program, offered by the Washington Association of Public Records Officers (WAPRO) that you may be interested in. There are other certifications as well.

As you may or may not know, it is perfectly acceptable under the Washington Public Records Act, §42.56 et seq., to make a public records request in person, as I did with you on October 22nd, 2025.

The relevant provision in law is in RCW 42.56.080(2):

"Agencies shall honor requests received in person during an agency's normal office hours, or by mail or email, for identifiable public records unless exempted by provisions of this chapter.

To make things easier for you and the Everett Public Facilities District, here is a written copy of my earlier in-person request. The Washington Public Records Act requires a response to this request be made within five business days.

Frankly, it seems it would take about 2 minutes to find the email addresses of the PFD Board members. But for reasons I do not know, you may indicate that these will be available November 28th as you did with my previous Public Record Requests.
